There are still a few administrative tasks that need to be done on the data protection/document retention side of things- basically, the plan for getting the records of the review to the archives needs your sign off, and we will need to write to all participants to let them know what the retention arrangements for their statements are. I am working on getting this all together and will send an email later in the week with a (hopefully very short!) list of tasks and documents for your views. Hopefully there shouldn't be anything too complicated or onerous.
