Good afternoon Richard,

Apologies for the delay in getting this information over to you, however please find a short summary of Prison to Rehab outcomes from the current financial year.

We have had 77 funding requests for P2R placements from 1 April 2025 – present. 6 of which have been considered to have fully completed their agreed placement period.

Some placements are still ongoing, but for those placements that have ended early or did not begin at all, please see below some of the factors that have contributed to this:

### **Did Not Enter Placement**

- Multiple individuals decided not to enter the programme on the day of liberation or after being offered a placement.
- Common reasons: family illness, change of mind, early electronic release, involvement in other issues.

### **Self-Discharge / Early Exit**

- A significant number of placements ended early due to self-discharge.
- Reasons include:
  - Wanting to return home to family.
  - Receiving benefits payment.
  - Securing housing
  - Struggling with programme requirements
  - Breaches of contract or challenging boundaries.
  - Aggressive behaviour toward staff/residents.

### **Aftercare Planning**

- Many cases note aftercare plans or packages in place, even when individuals self-discharged.
- Some declined aftercare or did not wish to complete planning.

## External Factors

- Criminal justice issues (e.g., additional custodial sentence, parole delays).
- Family emergencies (illness, need to support partner).
- Administrative issues

As we do not receive information on individuals after they leave their placement (whether early or not), we cannot confirm whether they continue their recovery journey beyond rehab. For this reason, we try to avoid considering placements that end early as unsuccessful. However, this remains a grey area due to the lack of follow up data.
