New policy

Screening

The Scottish Government's <u>Vision for Agriculture</u>, published in March 2022, outlines our long term vision to transform how we support farming and food production in Scotland to become a global leader in sustainable and regenerative agriculture.

After the UK withdrawal from the EU on 31 January 2020, our priority for agriculture and rural development was to provide stability and security for producers, land managers, and business. In 2020, the <u>Agriculture (Retained EU Law and Data)</u> (Scotland) Act was enacted to allow the Scottish Ministers to ensure that the former EU CAP (Common Agricultural Policy) payments and schemes would continue for a period of stability and simplicity after EU-exit.

In August 2022, the Scottish Government ran a public consultation titled '<u>Delivering our Vision for Scottish Agriculture: Proposals for a new Agriculture Bill</u>'. This consultation set out proposals to deliver the Scottish Government's Vision for Agriculture. The Agriculture and Rural Communities (Scotland) Bill will aim to provide Scotland with a framework to deliver high quality food production, climate mitigation and adaptation, nature protection and restoration, and wider rural development.

At the end of 2023, further changes made by the Retained EU Law (Revocation and Reform) Act 2023 came into force. The former retained EU law is now known as 'assimilated law'.

The new Agriculture and Rural Communities (Scotland) Bill aims to provide the

legal framework to enable delivery of numerous Scottish Government outcomes including, but not exhaustively:

- the Vision for Agriculture;
- the National Performance Framework outcomes;
- <u>Programme for Government</u> and Bute House draft shared policy programme priorities;
- emissions and nature restoration targets;
- building on minimum regulatory standards;
- Just Transition which supports agriculture, land integration and land use change in a way that follows the Just Transition principles;
- value for money;
- broad alignment to EU CAP objectives;
- Good Food Nation Act; and
- Local Food for Everyone
- Scotland's Forestry Strategy 2019-2029

The primary purpose of this Bill is to (i) provide the Scottish Ministers with the necessary powers to manage and in due course replace the current assimilated law Common Agricultural Policy framework for agriculture and land use support; and (ii) provide Scottish Ministers with the powers to deliver the Scottish Government's Vision for Agriculture. It also provides the Scottish Ministers with powers to make provision for continuing professional development (CPD) for farmers, crofters, land managers and other persons, and to continue support for wider rural development.

Payments Framework

The broadly framed enabling powers set out in the Bill allow for support payments for a range of specified purposes, including in response to exceptional or unforeseen circumstances in the sector. The powers also allow for changes to support in response to changing need, should the Scottish Ministers choose to do so.

Food and Drink

The enabling powers in the Bill will provide for financial support to food and drink businesses for a range of specified purposes, including in response to exceptional or unforeseen circumstances in the sector.

Climate and Nature

Through the support framework, the Bill enables the Scottish Government to deliver towards the outcomes of climate mitigation, adaptation and nature restoration, and ensure farming in Scotland can continue to produce our food more sustainably, and that the land is managed more sustainably. This will support delivery of outcomes and strategies, including the Climate Change Plan, Scottish National Adaptation Plan and Biodiversity Strategy.

Payments Administration & Data

It is essential that there is strong oversight of public money, and the Scottish Ministers are able by regulations to make provision for checking, enforcing, monitoring payments and evaluating progress to achieving the objectives of the Vision.

Support for Rural Communities and Rural Networking

The broadly framed enabling powers set out in the Bill allow for support to rural communities and for rural networking. They also allow for changes to that approach in response to changing need, should Ministers choose to do so.

Animal Health, Welfare and Genetic Resources

The Bill sets out broadly framed enabling powers that Scottish Ministers may to provide support for the protection, promotion and improvement of animal health, welfare and genetics in order to assist delivery the aims of the Vision for Agriculture.

Plant Genetic Resources

The power in the bill allows Scottish Ministers the power to provide support for plant genetic resources. Plant Genetic Resources are a public good and should benefit all by providing allowing greater potential for conventional breeding of viable plants for the future.

Access

The powers in the bill enable us to provide support to assist with the provision of public access over land. Where support is given, it will be based on the needs of that particular area with a view to ensuring improved public access and the ability of the public to exercise the right of responsible access as set out in the Land Reform (Scotland) Act 2003.

Forestry

The powers provided by this Bill will ensure that, as far as possible, forestry grant payments will continue to support the establishment, management and improvement of woodlands and support for the wider sector on matters including plant health and rural development. This will allow for the continued delivery of the objectives set out the Climate Change Plan and Scotland's Forestry Strategy.

Knowledge, innovation, education and training

The Bill includes new powers in respect of training and personal development relating to agricultural, forestry, land management or related sectors. This is in addition to provision of other forms of learning and sharing information, including provision of advice. It also includes new powers relating to innovation and other research and development activities which may improve or support rural communities, rural land or land use. There is also power to support these activities through the development, use and maintenance digital tools and resources.

In addition, the Bill provides the Scottish Ministers with powers to make provision for continuing professional development (CPD) for farmers, crofters, land managers and other persons.

Existing evidence

The Scottish Government does not record data on the characteristics in the Equality Act 2010 for the agriculture sector, but does record ages and gender of owner/occupiers of agricultural holdings with the most recent data available being from the 2023 Scottish Agricultural Census.

We only collect information on the owner/occupier's sex and age from the agricultural census. We also under the agricultural census collect data on employee gender only. The population Census Search | Scotland's Census - Search by topic (scotlandscensus.gov.uk) can provide further data on gender, race, disabilities etc, but the data does not allow detailed breakdown as it is limited to high-level general sectoral data.

The policies do not directly impact on the characteristics in the Equality Act 2010, but data is not collected as standard through agricultural censuses or surveys on it. Should it be required in the future then consideration can would be given on whether this data can be collected in the future to measure if the policies are having any impact.

In 2023 the majority of working occupiers were aged 45 years or over. Over the last 20 years the proportion of working occupiers aged 55 and over has risen from 49 per cent to 66 per cent. Between 2017 and 2021, an average of 63 per cent of working occupiers were aged 55 and over, in 2023 this was comparable at 66 per cent of working occupiers. In 2023, only 15 per cent of the total working occupiers were 44 or under.

Historically, more men have been associated with being an agricultural holding occupier. Between 2017 and 2021, an average of 39 per cent of working occupiers were women. In 2023 working occupiers followed a similar trend with 65 per cent being male and 35 per cent being female.

These estimates may not include some family members who also provide labour. In 2023 the Agricultural Census changed from asking about occupier and spouse to occupier and occupier 2 which included close family members including formalised relationships (married couples and civil partnerships), cohabiting couples and close family relationships (father, mother, daughter, son and sibling). While results may

be similar overtime there will be greater representation of different types of partnership from 2023.

A breakdown of the number of male and female occupiers by age category and working time in 2023 can be found below in Table 1.

Who will it affect?

The majority of this Bill will not have a direct impact on persons with protected characteristics, as it mainly provides Scottish Ministers with the powers to provide financial assistance for specified purposes, and to make regulations in connection with the provision of such assistance, rather than actual changes in policy.

Any policy changes that follow will be assessed for their impact on people and businesses, and further Impact Assessments, including an EQIA, will be carried out where appropriate.

Also, the enabling powers in the Bill that allow for regulations to be made for payments administration and the checking enforcing and monitoring of payments will not affect people with protected characteristics.

Payments Framework

The Payment Framework provisions in the Bill will not impact on any of the protected characteristics.

Food and Drink

The powers in the Bill will provide for financial support to food and drink businesses in all communities in Scotland. This will include support in response to exceptional or unforeseen circumstances in the sector. While the direct effect will be on

business, this in turn will have a positive impact on the wider community, including those with protected characteristics, through the potential for economic stability and growth, and jobs.

Climate and Nature

The provisions in the Bill will not impact on any of the protected characteristics.

Payments Administration & Data

The broadly framed enabling powers set out in the Bill allow for the Scottish Ministers to make regulations about (1) the provision of support to assist the creation of the new payment framework for the administration of payments and (2) the provision for the collection, processing and or sharing of data where that is necessary to ensure effective governance. These regulations and powers will enable the Scottish Ministers to enforce, monitor and evaluate progress to achieving the objectives of the bill and the Vision. These enabling powers in the Bill will not impact on any of the protected characteristics.

Support for Rural Communities and Rural Networking

The broadly framed enabling powers relating to support for rural communities and rural networking set out in the Bill will not impact on any of the protected characteristics.

Animal Health, Welfare and Genetic Resources

Implementation of the powers in the Bill will primarily affect keepers of livestock and associated businesses. Support for the designated purposes in Bill would be consistent with the responsibilities set out in the Equality Act 2010.

Plant Genetic Resources

Plant genetic resources are a public good. The powers in this bill give us the powers to provide support, which although would be provided to the protectors of the resource, the nature of the resources being protected will benefit society as a whole.

Access

The enabling powers in the Bill allow for support to be provided to support public access, and this will not impact on any of the protected characteristics.

Forestry

Enabling powers provided by this Bill will ensure that, as far as possible, the statusquo is retained and forestry grant payments can continue. Therefore, there is unlikely to be either a positive or negative impact on any persons with protected characteristics in the short term. Any changes to rules or administration of future forestry funding will be subject to further EQIA assessment where appropriate.

Knowledge, innovation, education and training

The enabling powers in the Bill relating to skills and knowledge will not impact on any of the protected characteristics. Any specific schemes or initiatives to encourage new entrants, including those with protected characteristics, as well as any specific schemes and initiatives for women in agriculture, will be subject to further EQIA assessment.

What might prevent the desired outcomes being achieved?

Payments Framework

The provisions in the Bill will enable to desired outcomes to be delivered Many details will be specified in secondary legislation, and separate impact assessments will be conducted during that period.

Food and Drink

The nature of the powers mean that the desired outcomes will be achievable, although the over-arching risk noted above regarding UK Government funding post-2025 applies here as it does to other policy areas.

Climate and Nature

The provisions in the Bill will allow delivery towards the outcomes of climate and nature. This will be subject to secondary legislation, budgets and the scale of what is required. For example, the overall level of emissions reductions will be established under separate plans and strategies such as the Climate Change Plan and Biodiversity Strategy.

Payments Administration & Data

The payment administration and data provisions in the Bill will enable Scottish Ministers to enforce, monitor and evaluate progress to achieving the objectives of the bill and the Vision. Secondary legislation will detail how this will be achieved and separate impact assessments will be undertaken at that time as appropriate.

Support for Rural Communities and Rural Networking

The nature of the broadly framed enabling powers mean that the desired outcomes will be achievable, although the over-arching risk noted above regarding UK Government funding post-2025 applies here as it does to other policy areas.

Animal Health, Welfare and Genetic Resources

The powers contained in the Bill will enable to desired outcomes to be delivered. This would include further consideration of equality during development of policies and legislation that may be required.

Plant Genetic Resources

The provisions in the bill will enable the desired outcomes to be achieved, noting the over-arching risk regarding overall funding.

Access

The provisions in the Bill will enable the desired outcomes to be achieved, noting the over-arching risk regarding overall funding.

Forestry

Enabling powers provided by this Bill will ensure that, as far as possible, the statusquo is retained and forestry grant payments can continue. As the Forestry Grant Scheme (FGS) is already well established it is unlikely that there would be any factors that prevent the continuation of forestry grant support, other than a loss of funding as outlined above.

Knowledge, innovation, education and training

The provisions in the Bill will directly allow delivery towards the outcomes relating to skills and knowledge and will also help to underpin the delivery of the other outcomes in the Vision of Agriculture. This will be subject to secondary legislation, budgets and the scale of what can be achieved with resources.

Stage 1: Framing

Results of framing exercise

The Agriculture and Rural Communities (Scotland) Bill builds on the public consultation on "Delivering our Vision for Scottish Agriculture: Proposals for a new Agriculture Bill'. The Bill reflects the stakeholder feedback received on the consultation.

A framing exercise was initially undertaken to consider the Equality Impact Assessment. The Bill is a framework bill and will enable the development and delivery of new schemes and policies on support. As a result, policies in the Bill are not quantifiable.

Protected characteristic: Age

Protected characteristic: Sex

Protected characteristic: Race/ Ethnicity

Protected characteristic: Religion or belief

Extent/Level of EQIA required

The 'Delivering our Vision for Scottish Agriculture: Proposals for a new Agriculture Bill' included a question to assist in determining the extent and level of EQIA

required such as:

"Are you aware of any examples of how the proposals in this consultation may impact, either positively or negatively, on those with protected characteristics (age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex and sexual orientation)? Please give reasons for your answer."

The consultation analysis noted that most responses did not give any examples of how the proposals in the consultation may impact those with protected characteristics.

It noted that some of the specific points were:

- there was a lack of focus on the impacts or inclusion of women throughout the consultation document,
- the impact of additional red tape on those with dyslexia,
- increased technological solutions impacting older people who may not have confidence with technology,
- little detail in the consultation in terms of support for young people,
- insufficient detail in the consultation on the impact of protected characteristics and that analysis needs to take place.

Further to this consultation there was substantial stakeholder engagement through the public consultation with nine in person events throughout Scotland (Inverness, Skye, Aberdeen, Oban, Scottish Borders, Stirling, Dumfries and Galloway, Ayrshire, and Orkney). In addition, five online events designed to ensure that views from across Scotland were heard.

The results of these engagements did not highlight any potential negative impacts that the Bill itself and the initiatives and policies covered within may have on certain groups. This has allowed any negative impacts to be considered thoroughly and ensured steps were taken to mitigate these. However, as the Bill is largely enabling it will have limited impact on equalities and protected characteristics. As such, minimal assessment is required at this stage.

The Scottish Government will ensure the teams working on future policy changes in secondary legislation are aware of the need to consult/further assess where appropriate.

This would normally include an EQIA being undertaken when future policies, that will follow on from the high-level legislation powers set out in the bill, are being developed. In due course.

Payments Framework

No impacts identified in relation to Payments Framework powers in the Bill.

Food and Drink

No impacts identified in relation to the food and drink provisions in the Bill.

Climate and Nature

No impacts identified, noting the Bill outlines climate and nature as a purpose of support, which will be delivered through the payments framework.

Payments Administration & Data

No impacts identified in relation to Payments Administration and Data enabling powers in the Bill.

Support for Rural Communities and Rural Networking

No impacts identified regarding the broadly framed enabling powers set out in the Bill.

Animal Health, Welfare and Genetic Resources

No negative impacts of the powers within the Bill on equalities and protected characteristics have been identified.

Plant Genetic Resources

No impacts identified in relation to plant genetic resources in the bill.

Access

No negative impacts have been identified in relation to access rights.

Forestry

No negative impacts of the powers within the Bill on equalities and protected characteristics have been identified.

However, these factors will need to be considered fully in relation to any future forestry policies to ensure there is due consideration of any impact, both positive and negative, on those with protected characteristics.

Knowledge, innovation, education and training

No impacts identified regarding the broadly framed enabling powers set out in the Bill.

Future consideration

While the proposals in the bill do not have any direct or indirect equality impacts, as noted above, it should be noted that a previous EQIA undertaken by Scottish Forestry relating to the Forestry Grant Scheme (FGS) indicated that 1 in 5 people in

Scotland label themselves as disabled, and 1 in 10 people are thought to be dyslexic. Previous research from onescotland.org carried out by partners in the rural sector indicated that those working in land based sectors typically have a higher rate of dyslexia than the average population, so the ratio may be higher for our staff and targeted customers.

The Scottish Agricultural Census (June 2023) also shows that the majority of working occupiers in Scotland are Men (65%) and women make up 35%. Further, the age profile of working occupiers shows that the majority (85%) are older than 45. Male and female working occupiers are generally similar ages.

While the above figures are notable, those with protected characteristics are not likely to be adversely impacted by the Bill as it is a framework Bill, providing a suite of powers for Scottish Ministers to provide support for various purposes. However, there is potential for those with protected characteristics to be impacted in the future when drafting secondary legislation or future guidance to support new rural payments schemes.

As such further consideration and equalities impacts assessment will be undertaken when developing future policy options for secondary legalisation proposals and subsequent support schemes, in due course.
