The panel talked about theme 5 with panel members sharing their experience and knowledge.




An **inspection** is when a service is looked at closely to see how well it is working.

The panel then looked at ways that would support and develop the workforce, and make sure services are always getting better.

The panel also discussed:



 registration - most job roles in the social services must register with the Scottish Social Services Council (SSSC)

The SSSC set the standards for the social care workforce.

• **standards** - what level of quality people should expect from a service



qualifications

Having **qualifications** means someone has passed exams or has completed a course.



• the importance of the wellbeing of the social care support workforce

Wellbeing means feeling comfortable, healthy and happy.



resources – money, materials and staff
