INTRODUCTION

This Circular amends Circular 1/2004 and revokes Circular 2/2007 and comes into force on April 6, 2013

1. This Circular draws attention to the Town and Country Planning (Fees for Applications and Deemed Applications) (Scotland) Amendment Regulations 2013 (SSI 2013/105).
2. The 2013 Regulations make no changes to the fees scheme other than increase the rates of fees and the fee maximum by approximately 20%.

4. These Regulations amend and should be read in conjunction with the Town and Country Planning (Fees for Applications and Deemed Applications) (Scotland) Regulations 2004 (SSI 204/219). These Regulations supersede changes made by the Town and Country Planning (Fees for Applications and Deemed Applications) (Scotland) Amendment Regulations 2010 (SSI 2010/141) and the Town and Country Planning (Fees for Applications and Deemed Applications) (Scotland) Amendment (No. 2) Regulations 2010 (SSI 2010/280).
