Suspected drug deaths in Scotland: October to December 2022

1. Background

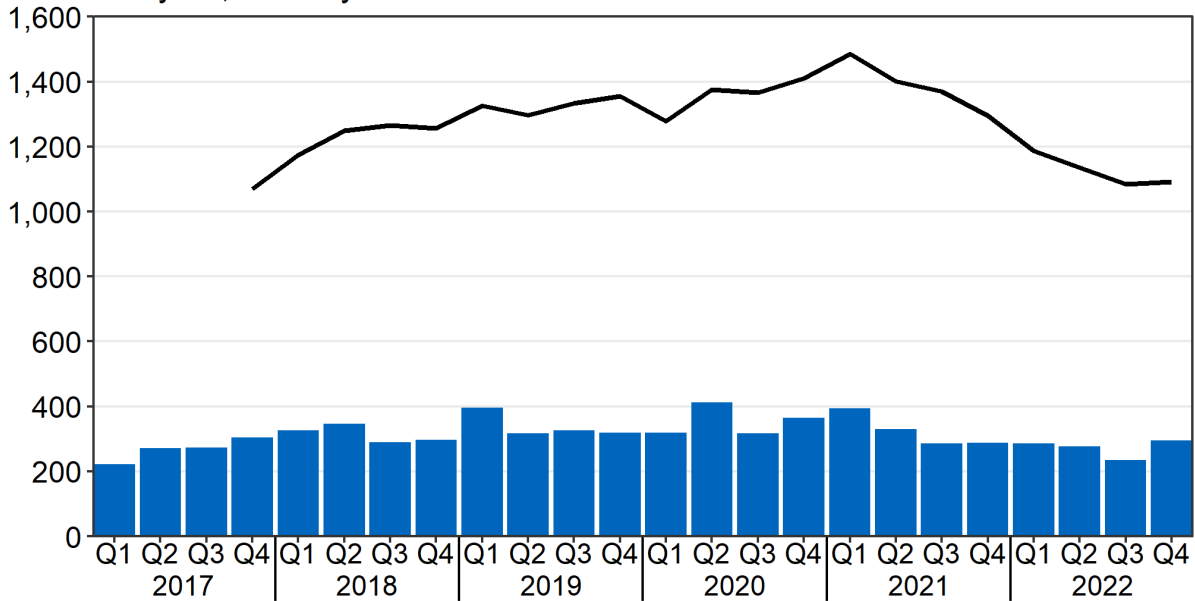
The Scottish Government has a National Mission to reduce drug deaths and improve the lives of those affected by drugs. This quarterly report presents Police Scotland management information to provide an indication of current trends in suspected drug deaths in Scotland.

2. Summary

There were 1,092 suspected drug deaths between January and December 2022. This was 16% (203) fewer than during the same period of 2021 (1,295). After a downward trend in the rolling 12-month suspected drug death total since early 2021, suspected drug deaths increased in the most recent quarter. There were 295 suspected drug deaths recorded over October to December 2022, 26% (60) higher than between July to September 2022 (235).

3. Main points

■ Police Scotland suspected drug deaths — Rolling annual suspected drug deaths (sum of last 4 quarters)

During 2022:

- There were 1,092 suspected drug deaths, 16% (203) fewer than during the same period of 2021 (1,295);
- Males accounted for 70% of suspected drug deaths. This compares with 73% between January and December 2021;
- There were 325 suspected drug deaths of females, a decrease of 9% (31) compared to the same period in 2021;
- A majority (66%) of suspected drug deaths were of people aged between 35 and 54. This is broadly in line with previous periods;
- There were 55 suspected drug deaths in the under 25 age group, 19% (13) fewer than between January and December 2021;
- The Police Divisions with the greatest number of suspected drug deaths were: Greater Glasgow (214), Lanarkshire (118) and Edinburgh City (113).

For quarter 4, October to December 2022:

- There were 295 suspected drug deaths recorded, 26% (60) more than between July to September 2022 (235), and 2% (7) more than the same calendar quarter in the previous year (October to December 2021, 288).
- This is the highest recorded number of suspected drug deaths recorded in a single calendar quarter since April to June 2021.

Note that numbers of suspected drug deaths fluctuate from quarter to quarter. Care should be taken not to interpret movements between individual calendar quarters as indicative of any long term trend.

4. Methodology

The data in this report is operational information from Police Scotland who compile figures on the basis of reports from police officers attending scenes of death. This is management information and not subject to the same level of validation and quality assurance as Official Statistics. National Statistics on drug deaths in Scotland are published annually by [National Records of Scotland](#).

5. Next update

Public Health Scotland (PHS) compile a [Rapid Action Drug Alerts and Response \(RADAR\) Quarterly report](#) of drug-related indicators in order to inform action to prevent drug harms and deaths. In January 2023, PHS added suspected drug deaths to their set of RADAR indicators, presenting weekly data on suspected drug deaths from Police Scotland. PHS will now publish data on this indicator quarterly, with the next publication due for release in April 2023. In light of this, Scottish Government, together with partners, will consider the future of the 'Suspected drug deaths in Scotland' report.

The next annual drug misuse deaths National Statistics publication from NRS is due to be released in Summer 2023.
