

Year One Delivery Plan

The Scottish Government and Justice Partners have a number of existing commitments which will help us deliver against the new Vision for Justice as detailed in the Programme for Government. A number of the key commitments and their relationship to the aims of the New Justice Vision are set out below. Action to deliver these commitments will span multiple years.

The year one delivery plan highlights the actions being taken forward in 2022/23 to help deliver the aims of the new Vision for Justice. The activity highlighted here is not a comprehensive account of all the relevant activity taking place across the Justice sector nor all the activity required for the successful delivery of the new Justice vision.

There will be an opportunity to review this one-year plan with our third sector partners, local authority partners and wider public sector in the subsequent development of a 3-year delivery plan. The 3 -year delivery plan will seek to set out the short medium and long term actions required to fulfil the new Vision for Justice. Work to develop this will take place over the coming months.
